Election Validity Watchdog United Sovereign Americans Responds to Florida Officials.

United Sovereign Americans (USA), a nonpartisan non-profit volunteer organization with chapters in 24 states, has responded to recent concerns raised by Collier Co Secretary of elections, Melissa Blazier. In an attempt to discourage local representatives from signing the common sense "USA Resolution for a Legally Valid 2024 Election" at the request of constituents, Blazier asserted that administering a valid election would force her to disobey Florida law. "By considering or even passing this resolution, the public's confidence in the elections that are conducted by the hundreds of Collier County citizen election workers who work hard to ensure fair, accurate and legal elections is further eroded."

However, Blazier breezed past the concerns specifically raised, that the Florida statewide voter registration list contains over 560,000 apparent registration violations, including 270,804 voters with likely invalid addresses, and over 12,000 voters with invalid names. These likely or provably ineligible registrants mysteriously cast over 117,000 votes in Florida's 2022 midterm election, calling into question the legal validity of outcomes certified as accurate and lawful.

Adding to the pile of unanswered questions are 145,309 votes counted and certified in that election from no voter whatsoever. Todd Buffington, State Chapter Director for USA in Florida, stated, "Our team of data professionals extracted these records directly from the state voter rolls, which federal law requires to be accurate. The voter rolls are part of our critical national security infrastructure. Why is Ms. Blazier not interested in working together to investigate these egregious problems? We aren't saying they are even necessarily in Collier County, but these potentially illegal votes could be affecting her voters by diluting their vote".

Without review, Blazier claims the USA Election Validity Scorecard for Florida's 2022 General Election, "lack(s) any manner of legally relevant evidence." However, the US Department of Justice prosecution guidelines define false registration as felony election fraud.

"Perhaps Ms. Blazier hasn't noticed that trust in elections is already low," continued Buffington. "What our citizen volunteers want is for these potential violations of the law to be investigated. Where is our process broken? The US Constitution grants the right and duty of choosing representatives to the people. USA findings indicate that someone out there may have their thumb on the scale, and we want it fixed before the upcoming presidential election. If our administrators don't want that, we will be forced to file suit."

United Sovereign Americans has identified over 17 million registration violations in the voter lists from just ten states, accounting for over 3 million votes in the 2022 midterms. USA has already brought a challenge to the validity of the voting system in the state of Maryland, has retained counsel in Pennsylvania and Ohio, and is preparing to file in more states.
