United Sovereign Americans Tracking Total Loss of Control Election Breach in Real-Time

Forensic auditors volunteering with United Sovereign Americans have been watching multiple data streams inside the early voting reports in Michigan, Texas, and other states. It is clear that there is a significant problem with counting duplicate votes, and the appearance, disappearance and reappearance of records and their votes. United Sovereign Americans releases data and/or findings only after completion of our rigorous internal testing and peer-review process.

This analysis-in-process has been prematurely reported on X, the Gateway Pundit, and perhaps other outlets as well. We are not clear whether the conclusions already being drawn are reasonable and can be verified. The data is not ready for prime time, yet.

What we do know, based on our analysis thus far, is that a marauder is active inside our voting system. This is a national emergency. United Sovereign Americans, a nonpartisan, volunteer Election Validity watchdog organization that has already filed federal lawsuits in nine states, using our unimpeachable evidence extracted from official records maintained by those states, is once again preparing emergency litigation to address the crisis. In the parlance of the Cybersecurity Infrastructure Security Agency, the federal agency tasked with oversight of all critical national infrastructure, it is a Total Loss of Control breach.

What we do not know yet is who the operator is and what their objective may be. What is at stake? Our freedom, our country, our prosperity and our future. The problems are being tracked by USA and directly measured. We are prepared to block this emergency. This is not a Michigan, Texas, Florida or Pennsylvania problem—it is a national problem. Haste makes waste.

Unlike many that have been shooting from the hip and raising millions of dollars, USA has been doing forensic analysis and evidence gathering for carefully constructed lawsuits. Almost 4 years ago, an information warfare specialist integral to the efforts of United Sovereign Americans proposed that a multi-step system of counting injected ballots could have been used by bad actors in the 2020 election, if not before. The purpose would be to bank desired votes and then move them from ‘undesirable’ or ‘unsafe’ voters to a real voter that did not actually vote.

Almost two years ago, under the direction of this ex-operator, United Sovereign Americans started designing a system that would measure this misconduct and Election Fraud. We comprehensively examined the voter participation history over time, tracking voters who had voted in previously certified elections and then disappeared, only to be “replaced” by new voters with backdated votes in those same elections. We call it “Vote Washing,” and our forensic, peer-reviewed work tracking millions of individual instances of this in the 2020 and 2022 elections on the following page.
