★ Why USA?

United Sovereign Americans (USA) has studied federal elections in 21 states and is the **FIRST** organization to **MEASURE** the current election misconduct as defined in criminal law. USA audits of official election records show as much as 30% of votes counted are improper (CA 2022 midterm).

- 1** Elections are not accurately measuring the intent of eligible voters submitting legal votes. The voters, votes, and counts are a constitutional and administrative disaster.
- 2** Election "integrity" solutions such as cleaning the voter rolls, eliminating machines, or requiring voter ID only address a small part of the problems that USA has exposed.
- 3** Political solutions last as long as the power of a politician or popular outcry. They cannot secure the enduring freedom America promises. Blue, Red, and Purple states have all been notified. They don't know what to do, or don't want to do anything.

What is the Risk?

USA's analysis shows the voting system is in a *Total Loss of Control* breach, a national cyber-infrastructure designation defined by the Department of Homeland Security. There **is** a marauder in our system whose intentions are currently unknown, and there is likely **more than one**. If cyber-infrastructure is compromised, how can Americans trust their votes represent their voice?

How do we secure liberty and prosperity for future generations?

USA Has the Solution: Real voters. Real votes. Real counts. Real proof. Only by securing every step of the election process, can we ensure that we have real representation and the Real America for which the citizens voted.
