**Re: Request for immediate action regarding the United Sovereign Americans election misconduct evidence reports for 2020 and 2022, sourced from official State records in twenty-one states.**

**Objective:** Secure the 2026 midterm election against further abridgments of the constitutional right of the American people to choose representatives in Congress, via investigation and prosecution of election misconduct, Constitutional enforcement, and legislation.

Our government was designed to protect individual liberty. Through fair and honest elections, each qualified American citizen is allowed one vote, all weighted equally. The United States Congress is endowed with the duty and authority to protect the sanctity of our federal elections, recognizing the minimum standards for a legally valid process: that the voters, votes, counts and process be authentic and transparent. In this way Congress fulfills its contractual obligation to guarantee a republican system of government to all citizens of the United States.

Our elections are critical infrastructure, falling under the jurisdiction of Homeland Security in part. Whether enemies are Domestic or Foreign, it is the job of our DOD, DOJ, DHS and IC to protect our country and its citizens against attack, including attacks on critical national security infrastructure. The extensive research into election misconduct by qualified data analysts, researchers, auditors and cyber forensics experts volunteering with the election validity group United Sovereign Americans (USA) is very disturbing.

It appears our voting system has been severely breached, a condition described by CISA as a Total Loss of Control. These findings are extensively documented from official data across more than half of the country's population, in twenty-one states. The facts point to a digital invasion of our elections, the process by which all authority is granted to our elected government. Whether the goal is to control, steal or destroy is unknown, but the conclusion that this is malicious is inescapable.

I am requesting immediate, decisive action be taken across all branches of government with the authority to address this matter, including the following specific actions.

### 1. INVESTIGATION AND PROSECUTION OF ELECTION MISCONDUCT:

Despite 21 comprehensive reports and 9 federal lawsuits being filed by USA, the findings were ignored by officials in the Departments of Justice and Homeland Security during the previous administration. I am requesting that the Department of Justice immediately open up a review and

investigation of the USA findings from 2020, 2022 and 2024. If warranted, I request that the DOJ act to secure future elections at the Federal and state levels by eliminating the apparently wide gaps in lawful election conduct. I additionally recommend that the DOJ aggressively prosecute those responsible, including those inside the Federal government, if offenses are found.

## **2. CONSTITUTIONAL ENFORCEMENT:**

Congress has the affirmative duty to secure our digital borders against invasion under the Guarantee Clause of the United States Constitution, Article 4 § 4. I request that Congress takes immediate action to secure our 2026 election and all future federal elections, enforcing the right to a republican system of government for every United States Citizen as the law requires. I request that any and all States that refuse to comply with the United States Constitution and laws regarding federal elections is sanctioned. A State that abridges the right to vote of its qualified citizens, including having that vote counted in the appropriate totals of votes, must lose apportionment as per the Fourteenth Amendment, Section 2. Failure to legitimize Congressional authority through a legally valid election process is a national betrayal that demands decisive, immediate action.

## **3. FEDERAL AND STATE LEGISLATION:**

The only way to return to our national aspirations of equality under the law, protection of our inalienable rights, and domestic tranquility is to restore faith in our elections for all Americans, regardless of party or ideology. United Sovereign Americans has a legislative solution to secure Real Voters, Real Votes, Real Counts, and Real Proof. I ask that Congress reviews and adopts this draft legislation prepared by qualified experts in Information Assurance and law, without deletions, securing the entire voting process against compromise or corruption.
