Why Are California Overlords Terrified of Election Validity?

ST. LOUIS, MO — On February 25, 2025, a group of California citizens visited their state representatives to discuss a proposal for election validity legislation. Part of a nationwide advocacy effort organized by United Sovereign Americans (USA), these volunteers met with numerous members of the Assembly Elections Committee, including Assemblymembers Bill Essayli and Carl DeMaio. Essayli, Vice Chair of the Assembly Elections Committee, co-authored Assembly Bill 25 (AB25) with DeMaio to require proof of citizenship for voter registration and mandate voter roll audits, which are common sense solutions for ensuring accurate elections.

In a shocking move raising concerns about political retribution, California Assembly Speaker Robert Rivas has now removed both lawmakers from their Elections Committee assignments.

USA Chairman Harry Hauray was disquieted by the move, saying, "The timing is alarming. The purge took place only three days after USA volunteers presented forensic evidence of massive election misconduct in California's 2022 and 2024 congressional elections to state legislators and staff, including Essayli's office, which was very receptive to USA's information and solutions. Citizens engaging with their representatives is the normal American process. It's how our government is supposed to work. The immediate revocation of committee seats suggests Soviet-style retaliation, right here in the land of the free." The data reviewed was extracted from official state records of federal elections, provided by the state to USA analysts and auditors.

Among extremely disturbing facts from the USA audit, it was discovered that **California counted 77,000 votes without any associated voter. 2,341,572 votes counted came from backdated registrations.** "Were these actual ballots? No one knows," continued Hauray. "How can an election for 52 seats in the House and one senator, Adam Schiff, be allowed to proceed when it fails a basic reconciliation of votes and voters? It's shocking, because our system of government by consent prohibits false representatives from defrauding or depriving citizens of our fundamental rights. Yet California has no idea if that may have happened here—and they clearly want to cover that up."

Are a majority of Californians voting for out-of-control spending, high crime, and cultural dismantling? The fact that California cannot definitively answer that question means that accountability must come. **One third of the votes counted in California's 2024 election are ascribed to invalid registrations,** another USA discovery in the state's own records. These voters are registered to vote before they are born, supposedly named asterisk, or have no name at all.

We must secure the inalienable rights of our great-grandchildren by regaining control of our elections. We cannot allow our Constitution to break.
