



Nevada Election Official Responds to USA's Request for Investigation

ST. LOUIS, MO – Three days after **Marly Hornik, CEO of United Sovereign Americans (USA)**, delivered a speech on election validity to nearly **8 million viewers**, a **Nevada election official responded to a complaint USA had filed with them** on July 10, 2024. The speech, delivered at Trump National in Palm Beach, Florida, on March 3, 2025, was streamed live via Stern America. It documented in devastating detail the failure of state election officials to enforce the law.

Hornik stated in her address: "We have a constitutional and legal disaster on our hands that cannot be fixed by the President. The Constitution says this one is up to the people. The current process for electing members of Congress nationwide is an uncontrolled, unmonitored catastrophe that is producing false returns. The return of American greatness is at grave risk of being sabotaged and destroyed, as early as 2026."

USA was the first to discover and document the algorithms and central vote manipulation. After tracking tens of millions of individual felonies in the 2022 election, USA filed their detailed data with states, the FBI, Homeland Security, and the DOJ under the previous administration, and filed nine federal lawsuits demanding that election commissions follow the law.

It appears that there are finally officials willing to take the information USA presented seriously, and conduct investigations.

USA had filed a 15-page complaint with Nevada officials detailing election law violations and irregularities. On March 6, 2025, **Compliance/Audit Investigator Darrell Harris from the Office of Nevada Secretary of State Francisco V. Aguilar reached out to Ms. Hornik to assure her that the complaint was still under investigation.**

All of us at USA are very grateful for Mr. Harris's decision to review our findings comprehensively. Astoundingly, he is the first person in the country from a Chief Election Official's office who has taken this step. "On behalf of USA, all Americans, and our future generations, we want to personally thank Mr. Harris and his office for their willingness to do something so simple and natural—listen and respond to the concerns of the citizens," Ms. Hornik stated.

She continued, "USA is proud of taking an approach that is actually starting to produce positive, productive results, and responses. We look forward to the substance of Nevada's report. We believe there are serious problems in our voting systems that must be deeply reviewed. In a beautiful country where we ascribe innocence first, we simply want to get to the bottom of this enormous problem with our elections and get back to having trust in outcomes—for all Americans, regardless of party or candidate."
