



Trump's Historic EO Confirms United Sovereign Americans Election Validity Movement

ST. LOUIS, MO – *Two forces—one citizen-led, one governmental—are closing ranks around a shared conclusion: America's elections are broken and fixing them requires more than trust. It demands proof.*

Both the Executive Order (EO) signed by President Trump on March 25, 2025, titled *Preserving and Protecting the Integrity of American Elections*, and the United Sovereign Americans (USA) law enforcement-compliant evidence and court filings, portray the US electoral system as fundamentally compromised and in need of rigorous overhaul.

The EO addresses enforcement and clarification of existing federal laws. It includes federal agency directives to guide compliance by state actors and prosecute election crimes.

The USA approach encompasses audits, civil litigation, and citizen advocacy to expose systemic failures and compel sweeping reforms and accountability.

Together, the EO and USA's "election validity" efforts could be viewed as complementary forces—one from inside the government enforcing compliance, the other from outside the government uncovering election misconduct and demanding compliance.

Where the Executive Order and USA Fully Align

These sections of the Executive Order mirror or explicitly support USA's goals, language, or procedural demands.

1. Citizenship Proof Is Non-Negotiable

- "...the Election Assistance Commission shall take appropriate action to require... documentary proof of United States citizenship..." (EO Sec. 2(a)(i-ii))
- ★ USA's "Real Voters" framework demands that only eligible, verified US citizens may be added to the voter rolls, a requirement in federal law.

2. Voter Rolls Must Be Verified, Not Assumed

- "...State and local officials [must have] access to appropriate systems for verifying the citizenship or immigration status..." (EO Sec. 2(b)(i))
- ★ USA emphasizes the need to purge ineligible and fictitious voters and has already identified 29 million materially deficient registrations from official voter registration lists.

3. Use Federal Databases to Support Voter Verification

- *"...Social Security and other Federal databases... to verify eligibility..." (EO Sec. 3(a))*
- ★ USA fully supports giving state and local election officials access to federal databases to help verify voter eligibility while protecting privacy and data security.

4. Illegal Voting Is a Crime, Not a Policy Gap

- *"The Attorney General shall prioritize enforcement of 18 U.S.C. 611 and 1015(f)..." (EO Sec. 2(e))*
- ★ USA views unlawful registrations and non-citizen voting as federal crimes defined by the Department of Justice, and demands swift legal action.

5. Paper Ballots, Not Barcodes

- *"Voting systems should not use a ballot... in which a vote is contained within a barcode..." (EO Sec. 4(b)(i))*
- ★ USA opposes any vote-counting process that obscures the voter's original intent or lacks a human-readable audit trail.

6. Ballots Must Arrive on Time—or Not Count

- *"...votes be cast and received by the election date established in law..." (EO Sec. 1 & 7(a))*
- ★ USA warns that delayed ballots break chain-of-custody requirements and cannot be counted.

7. Ballot Must Be Verified by the Voter

- *"...voting methods that produce a voter-verifiable paper record..." (EO Sec. 1)*
- ★ USA insists every step from registration through certification be provable.

8. Election Systems Must Be Recertified Under New Standards

- *"...review and, if appropriate, re-certify voting systems... rescind all previous certifications..." (EO Sec. 4(b)(ii))*
- ★ USA calls for compliance with federal law mandating comprehensive security reviews of every step of an election's process and equipment.

9. Cutting Off Federal Funds Forces Compliance

- *"...cease providing Federal funds to States that do not comply..." (EO Sec. 4(a))*
- ★ USA reports and lawsuits directly measure noncompliance with the Help America Vote Act, and can be used immediately to block disbursement of federal funds to states not operating inside the law.

These much-needed actions reflect a goal shared by President Trump and United Sovereign Americans to invalidate flawed systems and **restore compliance at every level—from equipment to personnel to law enforcement.**
