# USAACCOMPLISHMENTS



## Founded in June 2023, USA achieved the following in 18 months, prior to the 2024 election:

- Our combined litigation, advocacy, and public reporting of massive election misconduct contributed to absence of the mysterious

  18 million votes "missing" on election day 2024.\*
- Organized and mobilized over **3,000 volunteers** in **24** states
- Invested over **50,000 hours** in weekly, online, federal election law discussion and training sessions
- Analyzed 2022 election data in **21 states** and completed an "Election Scorecard" **measuring election misconduct** in each state
  - Aggregate data showed over 29 million registrations that are invalid under the law— 10+ million of which voted
  - Reported findings to state and federal officials for investigation

- Filed **9 federal mandamus lawsuits** in Colorado, Florida, Georgia, Maryland, Michigan, North Carolina, Ohio, Pennsylvania, and Texas
- Made **hundreds of appearances** on media outlets and podcasts across the country
- Presented our 'Resolution for a Legally Valid Election' at approximately **600 local town/county boards**
- Launched an **Election Misconduct reporting tool** for citizens to report 2024 election problems directly to state officials
- Raised **half a million dollars** to fund litigation and support volunteer organizational efforts
- Spurred the NYS Election Board to an initial audit of their deeply corrupt voter rolls
- Changed the national discussion from election "integrity" to "election validity"

USA is the FIRST organization to MEASURE the current election misconduct as defined in criminal law.



\*Deeply studied 7 large states—Illinois, Michigan, New York, California, Ohio, Pennsylvania, and Georgia—which control **168 Electoral College votes** and **35% of US Congress**, showing:

### **Aggregate Scorecard**

Data showed over **23 million** registrations invalid under the law—**7 million** of which voted—and **1.4 million** more votes were counted than voters who voted

### **2022 Election Fraud Report**

Performed voter identity verification prevalence studies showing:

- 21.6% of voters are unverifiable
  - 5.6% the voter does not exist
  - 12.3% the address is invalid
  - 3.7% vote to voter discrepancy

# **Vote Washing Report**

- 3+ million votes were altered, added or deleted in 2022 CERTIFIED election results at three distinct data pulls
- 4.3 million votes were altered, added or deleted in 2020 CERTIFIED election results
