



USA Submits Urgent Evidence to Congress Following California Election Hearing

ST. LOUIS, MO – Using multiple trusted skip tracing and identity verification databases, United Sovereign Americans (USA) investigators recently released results from a prevalence study of the 2024 election in Orange County, CA. The shocking results indicate that **one-fifth of the voters are likely non-citizens, invalid voters and/or simply do not exist at all.**

On April 29, 2025, the U.S. House Committee on House Administration convened a hearing titled “*Why the Wait? Unpacking California’s Untimely Election Counting Process.*” Lawmakers now have five days to submit relevant material into the official **Congressional Record**. USA is seizing that opportunity by delivering its evidence of election misconduct.

In addition to the Orange County study, USA’s report, titled “USA California Election Reports, Legal Relevance and Credentials,” details an even more deeply compromised electoral system in violation of multiple federal laws, including the Voting Rights Act, Help America Vote Act, and FISMA.

Key Findings from the 2024 election includes:

- **9.5 million voter registrations contain material omissions and errors**
- **5.6 million votes were cast by those voters**

Another prevalence study from the 2022 election in the state of California indicates:

- **1 million votes were counted from voters who do not exist**

And yet another study of the 2020 and 2022 elections showed that:

- **2.8 million votes were edited AFTER certification**

If it was accurate when it was certified why did it change? If it wasn’t accurate why was it certified?

VOTING SYSTEM PENETRATED, LEGAL MANDATES IGNORED

USA’s highly credentialed cybersecurity and data experts warn that the voting system infrastructure is not only riddled with invalid data, “dozens of successful attacks on our election systems were exposed.” USA analysts report, “these are not addressed simply by cleaning the voter rolls or eliminating voting machines. Federal security mandates have been waived or ignored for years. This is a national emergency.”

LAWMAKERS URGED TO ACT

USA is submitting its findings to the House Administration Committee, which includes Chair **Bryan Steil**, Ranking Member **Joe Morelle**, Vice Chair **Laurel Lee**, and members **Terri A. Sewell** (AL-07), **Barry Loudermilk** (GA-11), **Norma Torres** (CA-35), **Morgan Griffith** (VA-09), **Julie Johnson** (TX-32), and **Greg Murphy** (NC-03), urging each to enter USA’s evidence into the official Congressional Record.



USA CEO and Co-Founder Marly Hornik issued a strong warning. "CRITICAL VOTING SYSTEM CONTROLS HAVE FAILED—MASSIVELY," Hornik declared. "Actual California election results are unknowable," she added. "This is outright fraud on every American citizen and a direct threat to national sovereignty. California is illegally certifying uncontrolled election returns, whether knowingly or unknowingly."

A PATTERN IGNORED, A CRISIS DEEPENS

USA's previous reports documenting 2022 misconduct were sent to both state and federal officials before the 2024 election. Yet the same violations repeated—with equal or greater severity—in 2024.

CONGRESS MUST RESPOND

USA is calling on Congress to hold hearings and implement emergency reforms to secure legitimate representative government in 2026.
