Election Validity Under Attack: USA Stands with Wyoming Against Political Lawfare

ST. LOUIS, MO — United Sovereign Americans (USA), a nonpartisan civic organization committed to restoring the fundamental right of every American to legitimate representative government through legally valid elections, announced its support for Wyoming's newly enacted election law, HB 156. The measure establishes a 30-day residency requirement and mandates documentary proof of U.S. citizenship for voter registration—reforms USA calls essential to upholding the integrity and validity of elections.

"HB 156 is not just sound policy—it's a constitutional necessity," said Marly Hornik, Executive Director of United Sovereign Americans. "States have a dual responsibility under federal law: to prevent the denial of the vote and to guard against its dilution with invalid ballots. Wyoming has taken a reasonable step to fulfill both."

USA's mission is rooted in securing election validity by linking votes to verified voters and ensuring that only qualified citizens participate in the democratic process. The organization conducts forensic investigations using public records and criminal law standards to expose wide-spread vulnerabilities in current election systems.

The passage of HB 156 comes as activist groups, led by attorney Marc Elias and the Equality State Policy Center, file suit to block its implementation. Secretary of State Chuck Gray has pledged to defend the law vigorously. USA stands firmly with him.

"We are not dealing in hypotheticals," Hornik continued. "Our forensic research into public data has identified over 8 million apparent unlawful votes counted across seven states in the 2022 midterm elections. These numbers are not projections—they are documented failures that already injured the civil rights of legitimate voters and compromised the rule of law."

Among USA's findings:

- **2,189,483** votes counted were linked to "voters" who do not exist.
- **4,840,975** were attributed to voters who did not live at the voting address.
- **1,449,054** votes were counted with no corresponding voter.

These findings suggest a vote dilution crisis affecting over 20% of certified votes in key federal elections.

USA emphasizes that this data is not speculative—it comes from public records analyzed under existing legal definitions of criminal election fraud.

HB 156 is fully consistent with the Voting Rights Act [52 U.S.C. § 10101(a)(2)(B)], which requires states to protect the vote both from suppression and from dilution through fraud. The Wyoming law's list of acceptable documents—including state and tribal IDs, passports, naturalization certificates, and birth certificates—offers clear, accessible pathways to compliance without undermining lawful participation.



"The threat of disenfranchisement has been the rallying cry against voter ID laws for years," Hornik said. "But when measured with real data, it's a paper tiger. What's been overlooked is the quiet, measurable erosion of valid votes—vote dilution—caused by unverifiable registrations and millions of phantom ballots."

As Elias and allies seek to use Wyoming as a test case to undercut national election validity reforms like the federal SAVE Act, USA is sounding the alarm. "Guarding the link between voters, votes, and tallies is a statutory requirement—not a political preference," said Hornik. "It's time the law was enforced."

USA applauds Secretary Gray's commitment to defending HB 156 and ensuring that Wyoming leads the nation in protecting the sanctity of the vote. "This law doesn't disenfranchise—it restores confidence," she concluded. "Because in the end, it's only a Republic if we can keep it."
