



## **Marly Hornik, USA CEO and Co-Founder**

Organized first national effort to measure current election misconduct as defined in criminal and civil rights law. Engaged hundreds of skilled and credentialed volunteers to complete an audit of official records from certified federal elections, in twenty-one states, regarding the federal elections in 2020, 2022 and 2024. This includes:

- Overseeing submission of Suspicious Activity Reports (SAR) to State officials as well as the DOJ, FBI and DHS.
- Constructing legal framework, hiring attorneys, gathering plaintiffs, and filing nine federal lawsuits with a call for enforcement of existing laws.
- Over 30,000 teaching hours in weekly, online public lecture and discussion on Election Validity and inalienable rights.
- Presenting evidence and constitutional analysis to state and federal legislators, prosecutors and election officials and highlighting specific constitutional remedies that are within their authority.
- Designing initiatives for volunteer advocacy efforts, including directly with representatives.
- Designing and leading national educational seminars and training conferences in Election Validity.
- Publishing op-eds in national outlets such as *Daily Caller*, *TownHall*, *American Greatness*, *American Thinker*, *Blaze* and more; as well as appearing on WarRoom, The Absolute Truth with Emerald Robinson, America's Sunrise, America Shines, as well as Frank Gaffney, Bob Frantz, and others.

### **NEW YORK CITIZENS AUDIT, Founder and Executive Director**

Organized and inspired 2,000 volunteers to contribute to a comprehensive investigation of New York's certified 2020 and 2022 election records. This included:

- Coordinating a credentialed voter data analytics team, hundreds of FOIL requests and analysis of evidence.
- Writing a "Petition for Redress of Grievances pursuant to the First Amendment" regarding the 2020 general election in New York, launching a signature gathering initiative, and training volunteer teams to present the document to County Legislatures, County election bureaus, sheriffs, and District Attorneys, as well as the NYS board of elections, NY Attorney General, and the state offices of the Democratic and Republican parties.
- Writing a "Resolution for an End-to-End Audit of New York's 2022 General Election," incorporating law and precedent with evidence extracted from official election records, and training volunteers to present the document over 500 times at town board meetings across New York State.
- Organizing and launching the first statewide, randomized, statistically valid physical canvass effort to study the effect of corrupted registration and voting data on election outcomes.
- Briefing sheriffs, District Attorneys, detectives, the bicameral NYS Legislature Election Law Committees, and the NYS Police Special Investigations Unit on election misconduct evidence gathered and analyzed by NYCA.
