USA Thanks Arkansas Secretary of State Cole Jester for Election Validity Leadership

ST. LOUIS, MO — United Sovereign Americans (USA), a national election validity research and advocacy organization, congratulates Secretary Jester on providing true leadership in the fight for accurate and compliant elections. Jester has led the way on meaningful reforms that fulfill the first directive of the US Constitution: that qualified citizens, as defined in state law, choose their representatives. As a result, Arkansas has been ranked first in the nation for election security by the Heritage Foundation.

Jester's actions include joining the federal SAVE program to check voter registration against department of homeland security records; partnering with credit bureaus to make sure individuals live where they say they do when registering to vote; establishing voter IDs for initiative petitions; checking for voter registration anomalies, such as individuals registered at industrial addresses or several individuals with the same name at the same address; auditing the remakes of damaged ballots; requiring a witness for absentee voting, who must leave contact information, and requiring federal juror coordinators to tell the Secretary of State when they find jurors who are noncitizens but registered to vote.

USA CEO Marly Hornik stated, "This kind of bold leadership is sorely needed all over the country. In 2023 and 2024, USA brought comprehensive reports of millions of non-compliant voter registrations, along with the invalid votes they cast, to chief election officials in 22 states. They all denied the problems, leading USA to file nine federal lawsuits. Jester has courageously chosen to secure elections and protect national sovereignty at a time when that draws significant fire. Not only is Arkansas now committed to rigorous identity verification of voter registration applicants, but Jester has creatively chosen to cross-check each applicant's address with private, commercial databases, which are often far more accurate than some government tools."

USA has conducted numerous studies of voter identity nationwide, uncovering shocking numbers of votes counted from voters who do not exist. "Fake people are definitely not citizens," noted USA Chairman Harry Haury, a credentialed expert in cybersecurity. "When we studied Orange County, California's 2024 election, we found that over 74,000 of them had voted. Californians and all Americans were disenfranchised when six House seats were certified in that election. One in every five votes appears to have been illegally counted in an election that was pure theater. So it's very heartening to see the opposite in Arkansas."

"Our founders knew the only way to secure liberty was legitimate representative government," continued Hornik. "USA applauds Secretary Jester, and we thank him for fearless loyalty to the US Constitution and Arkansas state law."
