USA's Hornik: How Could Judge Allow Wacky NY Lawsuit Accusing Trump of Election Cheating to Proceed?

ROCKLAND COUNTY, NY — United Sovereign Americans (USA), a national civic organization fighting for legally valid elections, has denounced a “wacky” lawsuit filed in New York state that accuses President Donald Trump of cheating in the 2024 election, even though he lost the state.

While anyone can file a frivolous lawsuit and nearly all are quickly dismissed, this one, filed in Rockland County, New York, has been allowed to proceed despite absolutely NO evidence to support it. It appears that plaintiffs have been granted “standing” not because of the merits of their speculative claims, but due to a biased court system that ignores important voting rights concerns and simply pursues President Trump.

Calling out the judge responsible for this insanity, New York Supreme Court Judge Rachel Tanguay, USA CEO Marly Hornik called her “yet another black-robed Priest of Progressivism” in a new Op-Ed piece. At taxpayer expense, Hornik points out, the case is “proceeding to discovery and a possible vote recount.”

Does Ballot-Splitting Really Equal Cheating?

Central to the suit is the contention that vote-splitting outside of typical levels itself indicates election fraud. “The lawsuit claims that because more than 900 people in one district voted for incumbent US Senator Kirsten Gillibrand (D-NY), just two for Democratic presidential candidate Kamala Harris and greater than 900 for President Trump, the latter must have ‘cheated,’” Hornik adds.

Hornik contends that many other political factors can explain localized ticket-splitting in any one election. These could include candidates on a regional or statewide ticket who grew up in that county or have other personal ties, the amount of campaigning done there, or particular issues specific to the area.

Initial Plaintiff Withdrew From Case

Incredibly, the case was originally about an entirely different issue, a number of undercounted votes in the US Senate race that affected independent candidate Diane Sare. When Sare realized her action had been hijacked by others and turned into an anti-Trump crusade, she immediately withdrew.

“Sare voters were mysteriously disenfranchised, which should be investigated by law enforcement. This is especially concerning given the same thing happened in her 2022 run against Senator Chuck Schumer (D-NY),” Hornik indicated.

Real New York Voting Issues Aren't Heard At All

Hornik believes such frivolous suits provide a smokescreen: “Meanwhile, the fact that “deep Blue” New York has massive issues with election validity statewide continues to be ignored. A prevalence study from credentialed experts at United Sovereign Americans attempting to validate actual voters in the state’s 2022 midterm shows that almost 129,000 of them don’t exist. Additionally, at least 745,000 votes were counted improperly, according to official records maintained by the state board of elections,” she added.
