* Extracted from responses to public records requests made in February 2024 to 351 municipalities for voter registrations and voter activity in the 2022 General Election. Responses were received between February and May, 2024. In violation of Massachusetts Public Records Law Mass. General Laws ch. 66, sec. 10, 24 municipalities failed to provide voter registration files, and 26 municipalities failed to provide voter activity files.

**Official count of 2,511,461 reduced by 101,890 votes for 26 towns that neglected to provide voter activity files.
