Nearly 15% of Ballots in Illinois and Texas are Haunted by Phantom Voters

DALLAS, TX & CHICAGO, IL—As Halloween approaches, Unite4Freedom (U4F) continues to shine a light where shadows often fall with the release of two new non-partisan reports examining voters in the 2024 election in Illinois and Texas. While the states differ in politics and geography, Unite4Freedom's (U4F) Phantom Voter Reports share an eerily similar outcome.

In the 2024 general election, 14.9% of voters in Cook, Dupage, Kane and Winnebago Counties in Illinois, and 14.2% of voters in Dallas, Harris, Travis and Tarrant Counties in Texas, are "phantoms"— either nonexistent or ineligible under the law. That translates to nearly one million inadmissible ballots in those eight counties—a frightening number—that fall short of federal admissibility standards.

Using the same resources available to banks, courts, and law enforcement, the U4F study determined that these voters had virtually no other footprints in their respective counties beyond casting a ballot in the 2024 election.

This work isn't about red or blue—it's about transparency and truth. Whether you live in the Heartland or the Hill Country, trust in the electoral process matters to every American. Every legitimate voter deserves to have confidence that her or his voice isn't diluted by phantoms in the system.

Unite4Freedom calls on the Secretaries of State in Illinois and Texas to immediately:

- Release complete 2024 voter-record data for independent review.
- Suspend unverifiable registrations until third-party audits confirm eligibility.
- Adopt continuous identity verification standards before 2026.

Unite4Freedom also urges citizens in Illinois and Texas to help exorcise the phantoms from their elections by helping us share the truth and demand reform.

This study measures suspected fraudulent registration and voting in the 2024 election in Cook, Dupage, Kane, and Winnebago Counties, IL. The study was conducted using the Unite4Freedom copywritten process for performing comprehensive identity verification using commercially available fraud-prevention tools.


A randomized sample of 609 voter records, taken from the entire population of 2,921,366 voters in the 2024 election, was generated based on a 90% confidence interval, a precision of 0.02 and a predicted prevalence of P = 0.1.

The first check of the data is to see if the voter "exists" in any of the identity verification databases used and if there are address or other compliance issues. Only the people who pass the first check are run through the SSN check. Identities that fail one of the checks are not run through additional checks to ensure they are not "double counted."

When extrapolating the sample results to the population of vote records in the 2024 election in Cook, Dupage, Kane, and Winnebago Counties, IL, the following was found:


A randomized sample of 608 voter records, taken from the entire population of 3,811,944 voters in the 2024 election, was generated based on a 90% confidence interval, a precision of 0.02 and a predicted prevalence of P = 0.1.

The first check of the data is to see if the voter "exists" in any of the identity verification databases used and if there are address or other compliance issues. Only the people who pass the first check are run through the SSN check. Identities that fail one of the checks are not run through additional checks to ensure they are not "double counted."
