



## Statement from Unite4Freedom Chairman Harry Haury on Georgia Election Evidence

CHESTERFIELD, MO — At Unite4Freedom, we fully support the DOJ, FBI and ODNI seizing possible evidence in Georgia. We have worked for years, mostly behind the scenes, with the Georgia State Board of Elections, Garland Favorito's VoterGA, our State Chapter, and other Georgia patriots to help expose the deep corruption of elections and election processes in Georgia and Fulton County.

We hope that the seizures result in the development of additional evidence, arrest, and prosecution of those responsible. We believe that the State of Georgia along with many others need to make a clear agreement to:

- 1) Faithfully follow existing law,
- 2) Know definitively who is voting and that they are eligible to vote,
- 3) Know that the ballots counted came from the voter's hands,
- 4) Know that all the legitimate ballots submitted were counted accurately, and
- 5) Prove through legitimate comprehensive and randomized audits that the election outcomes are valid.

Unite4Freedom has developed hard evidence of massive election fraud across the country due to Malicious, Ignorant and Apathetic (MIA) behavior. Our Election Officials and State executives can no longer be MIA.

Thousands, and in some instances millions of votes in each state, certified as accurate by election officials, originate from records that call into question the voter's identity and eligibility under defined criminal law.

Our studies show dozens of successful attacks on our election systems, that cannot be addressed simply by cleaning the voter rolls or eliminating machines. Federal election security mandates under the Voting Rights Act (VRA), National Voter Registration Act (NVRA), Help America Vote Act (HAVA), and Federal Information Security Modernization Act (FISMA) have been waived or ignored for years, resulting in fully penetrated voting systems.

States are illegally certifying uncontrolled election returns, knowingly or not. THIS IS A NATIONAL SECURITY EMERGENCY.

We are willing to work with any government official who wants to investigate the significant issues we have exposed. We have a team of analysts ready and willing to assist.

We hope this is just the beginning of Federal action to hold these criminal actors responsible for their misconduct and return fair, open and honest elections! It is time to stop the lie that voter fraud does not exist, we have the proof of millions of cases across the country.
